Procedure

If any student or group of students found guilty of ragging in the campus, he/she will be liable to the punishment. A written complaint can be put in a complaint box of the college. He/she can directly write to the Co-ordinator or a member of Anti-ragging Committee. He/she can also call to coordinator of committee members. If there is a case of ragging, the committee looks, into the matter and brings to the notice of the chairman of the institute. The Anti-ragging Committee shall complete the inquiry and submit its report along with recommendation to the chairman of the Anti-ragging committee of the institute within fifteen days of the incident
